### SECTION 7. Handling and storage

#### 7.1. Precautions for safe handling

##### Safe use of the product

- : Use only properly specified equipment which is suitable for this product, its supply pressure and temperature. Contact your gas supplier if in doubt.
- : Only experienced and properly instructed persons should handle gases under pressure.
- : The substance must be handled in accordance with good industrial hygiene and safety procedures.
- : Do not smoke while handling product.
- : Ensure the complete gas system was (or is regularly) checked for leaks before use.
- : Consider pressure relief device(s) in gas installations.

##### Safe handling of the gas receptacle

- : Refer to supplier's container handling instructions.
- : Do not allow backfeed into the container.
- : Protect cylinders from physical damage; do not drag, roll, slide or drop.
- : When moving cylinders, even for short distances, use a cart (trolley, hand truck, etc.) designed to transport cylinders.
- : Leave valve protection caps in place until the container has been secured against either a wall or bench or placed in a container stand and is ready for use.
- : If user experiences any difficulty operating cylinder valve discontinue use and contact supplier.
- : Never attempt to repair or modify container valves or safety relief devices.
- : Damaged valves should be reported immediately to the supplier.
- : Keep container valve outlets clean and free from contaminants particularly oil and water.
- : Replace valve outlet caps or plugs and container caps where supplied as soon as container is disconnected from equipment.
- : Close container valve after each use and when empty, even if still connected to equipment.
- : Never attempt to transfer gases from one cylinder/container to another.
- : Never use direct flame or electrical heating devices to raise the pressure of a container.
- : Do not remove or deface labels provided by the supplier for the identification of the cylinder contents.
- : Containers should be stored in the vertical position and properly secured to prevent toppling.

- : Keep container below 50°C in a well ventilated place.
- : Observe all regulations and local requirements regarding storage of containers.
